In the Flemish Region about 6,5% of the people of 18 years or older do not have the Belgian nationality. People living in Belgium with the Belgian nationality have the right to vote in elections (in fact voting is compulsory), have the right to stand for elections, and last but not least, having the Belgian nationality is a prerequisite for statutory jobs in public office. However, due to the 'snel-Belg-wet' (a law, passed in 2000, which under certain conditions give the right to the Belgian nationality) many people obtained the Belgian nationality in the last decennium.

So, only asking the question whether the respondent has the Belgian nationality or not, does not give an adequate picture of the country/place of origin.

To get an idea of the nationality of the parents of the respondent, questions are asked whether the father and the mother have the Belgian nationality from birth.

Based upon those three questions a distinction is made between only two categories:

- 1) Respondents with the Belgian nationality and parents both born with the Belgian nationality.
- 2) All other respondents. Further detailed and workable distinctions are not possible due to the limited number.
