## **TECHNICAL SPECIFICATIONS**

Between the 3<sup>rd</sup> and the 23<sup>rd</sup> of September 2015, TNS political & social, a consortium created between TNS UK and TNS opinion, carried out the survey FLASH EUROBAROMETER 427 in the NUTS 1 and 2 regions of the European Union.

It is a general public survey requested and co-ordinated by the Directorate-General for Communication ("Strategy, Corporate Communication Actions and Eurobarometer" Unit). The FLASH EUROBAROMETER 427 covers the population of the respective nationalities of the European Union Member States, resident in each of the 28 Member States and aged 15 years and over. In each country, 300 interviews were carried out in each NUTS region (NUTS 1 or 2 level) except in Åland (Finland), Ciudad Autónoma de Ceuta and Ciudad Autónoma de Melilla (Spain) where 150 interviews were conducted.

NUTS 1 regions were surveyed in Belgium, Germany, Greece and the United Kingdom.

NUTS 2 regions were surveyed in Austria, Bulgaria, Croatia, Cyprus, Czech Republic, Denmark, Estonia, Finland, France, Hungary, Ireland, Italy, Latvia, Lithuania, Luxembourg, Malta, the Netherlands, Poland, Portugal, Romania, Slovakia, Slovenia, Spain and Sweden.

TNS have developed their own RDD sample generation capabilities based on using contact telephone numbers from responders to random probability or random location face to face surveys, as seed numbers. The approach works because the seed number identifies a working block of telephone numbers and reduces the volume of numbers generated that will be ineffective. The seed numbers are stratified by NUTS region and urbanisation to approximate a geographically representative sample. From each seed number the required sample of numbers are generated by randomly replacing the last two digits. The sample is then screened against business databases in order to exclude as many of these numbers as possible before going into field.

This approach provides a consistent approach across all countries.
