We have very clearly given in Interviewer instructions; as mentioned in the current BVQ document; that by “attaining” any year means “completing” that year in education.</i></b></p> <p><b><i>This is different from our first round of ISSP (ISSP: Family and Changing Gender Roles) where our routine Country-Edu question only asked “Up To” while the ISSP coding required as “Completed”. We had to correct that anomaly by recoding the “Up to Primary” in “Completed Primary” based on the “Edu_Years” to make it at par with ISSP coding.</i></b></p> <p><b><i>As per our discussion with ISSP after our submission of that dataset; we changed our country education question from “up to” to “complete”;</i></b></p>	

	<p><i>asking clearly for the “Completed” education and writing it verbatim to avoid any confusion whatsoever; so that it is fully in sync with the ISSP coding. Kindly refer to the “Interviewer Instruction” on BVQ_04 above.</i></p> <p><i>However we still have issues to deal with “Non-Formal Education” which includes “open-schooling” format or “private examination” format. For No Formal Education details – In India, open schooling is available in almost all parts of the country.</i></p> <p><i>So people may not have formally gone to school but there are big number of cases where people have taken examinations directly as “Private” student.</i></p> <p><i>The Indian Education boards allow them to appear different examination just by virtue of being 15 / 17 or 21 years of age. These students study on their own; without going to any formal schooling; but appear in High School; Intermediate or College examinations. This is very different from “Compulsory Schools”.</i></p> <p><i>Then there is big number of students studying in “Madarasas” or “Islamic Schools” which in many cases are not treated as “Formal Schools” and their certificates may or may not be considered at par with High School or College graduations depending on Federal laws and states. We have no other option but to keep them in “Non-Formal” education and explain them accordingly.</i></p>
