<i>Translation:</i>	Questionnaire was provided by EUI in local language and the fieldwork agency was asked to review and suggest changes if necessary. Changes were then either accepted or rejected by EUI.

Sampling, weighting

I.1 Fieldforce

In Spain the fieldwork team consisted of 33 interviewers, 2 supervisors and 1 fieldwork coordinator.

Interviewers – according to the eligibility criterion - had all at least one year of experience as an interviewer (1.7 years in average, maximum 15 years). All the interviewers attended the official training for the EES which was held on the 5th June by the project manager.

EES interviewers also received written interviewing manual, with special focus on the following issues:

- Details about the survey
- Selection of eligible respondents
- Instructions for conducting of interviews
- Additional information on questions of the questionnaire

III.3 The use and estimated effectiveness of the response enhancement techniques

Two short open sessions with interviewers, held at the beginning of each work-shift on the 9th June to remind the major issues of this project, and the way of dealing with following situations:

- Usage of hints/statements listed in the interviewer manual for getting reluctant respondents to participate
- Explain to the interviewees the statistical goal of questions where a significant number of respondents were reluctant to answer and tell them that under no circumstances their individual answers would be released.
- Remind periodically respondents that their opinion counts and that the survey is taking place throughout Europe.

Interviewers reported that they used almost all the hints Gallup suggested in the interviewer manual and they often managed to persuade interviewees to take part in the survey. Respondents were more likely to answer the questions if interviewers confirmed at the beginning that they do not want to sell anything.

III.4 Soft refusal conversion

In case of soft refusal, an experienced interviewer (other than the one who called the respondent previously) specifically trained for this task called up the respondent, politely introduced the survey again and asked for cooperation. If respondent refused this time too, no more contacts were made with him/her. If the person was cooperative, the interviewer conducted the interview. It could happen that the respondent was willing to take part but did not have time to complete the survey at the time of the re-call, in this case interviewer fixed an appointment with him/her.

The results of these attempts are summarised in the table below:

IV. Qualitative report of the fieldwork agency



In their own words:

Supervision:

- Method: Simultaneous listening with real Q're viewing on Supervisors' computers.
- Supervision rate: 12,5% of total interviews.
- Interviewers supervised: 100% interviewers.

The supervision has been carried out focusing on the following priorities:

- New interviewers working with us (they were supervised 25% of their work, 60% the first day)
- The recruitment and procedures to turn soft-refusals into completes
- Selection criteria to choose eligible respondent: in order to ensure the respondent is the very last one, who had the most recent birthday among the 18+ household members.
- Demographics

The minor issues detected during the simultaneous listening were:

- Q1, Q2 & Q3: general verbatims collected.
- Q25, Q26, Q27 & Q28: some respondents refused to answer.
- Q40-Q45, Q56-Q67: scale limits are not always recalled to respondent.

Measures implanted:

Two short open sessions with interviewers, held at the beginning of each work-shift on the 9th June to remind the major issues of this project, and the way of dealing with those situations:

- Q1, Q2 & Q3: Explanations on how to prompt for full-sense verbatims.
- Q40-Q45, Q56-Q67: Remind periodically the meaning of the scale limits
