Chapter three *Data, Structure and Standards* provides an overview of the dataset, the content and describes data preparation and harmonization processes.

Chapter four provides a short explanation of the variable documentation itself.

Chapter five contains the core variable documentation: the documentation of each variable including complete question texts with all answer categories of the harmonized data, deviating code values in the source datasets. This is complemented by additional notes and, where applicable and necessary, a brief description of the data harmonization procedure.

Chapter six, the appendix, contains the ISCO88 coding scheme and the URBRURAL recode for 1991.

1 ISSP series description

1.1 Series name

The International Social Survey Programme (ISSP)

1.2 Series information

The ISSP is a cross-national collaboration program, which has been continuously conducting annual surveys on diverse social science topics since 1985. The topics for each ISSP survey are proposed by delegates from ISSP member countries. Then, a Basic Questionnaire is composed by a committee, elected by the General Assembly before it is pretested in various countries. Starting in 1984 with four founding nations - Australia, Germany, Great Britain, and the United States, the ISSP meanwhile has grown up to almost 50 member countries covering various cultures around the globe.

3 Data, structure, and standards

ISSP *Religion I-IV* cumulates the data of the integrated data files of

- ISSP 1991 (ZA2150 Data file Version 1.0.0, <https://doi.org/10.4232/1.2150>),
- ISSP 1998 (ZA3190 Data file Version 1.0.0, <https://doi.org/10.4232/1.3190>),
- ISSP 2008 (ZA4950 Data file Version 2.3.0, <https://doi.org/10.4232/1.13161>, ZA5690 Data file Version 1.0.1 <https://doi.org/10.4232/1.11762>) and
- ISSP 2018 (ZA7570 Data file Version 2.1.0, <https://doi.org/10.4232/1.13629>, ZA7630 Data file Version 1.0.0 <https://doi.org/10.4232/1.13517>)

It comprises data from all ISSP member countries that participated in at least two Religion modules. The data set contains:

- cumulated topic-related (substantial) variables, which appear in at least two Religion modules and
- background variables, mostly covering demographics, which appear in at least two Religion modules

3.1 Content

Assessment of personal happiness; responsibility of government for providing jobs and reduction of the difference between rich and poor; attitudes towards sexual relations before marriage; attitudes towards sexual relations with someone other than spouse; attitudes towards homosexual relationships between adults; attitudes towards abortion in case of serious disability or illness of the baby or low income of the family; attitudes towards gender roles in marriage (husband earns money, wife's job is family, family life suffers if women works fulltime); attitude towards tax fraud and incorrect information to get benefits from government; trust in institutions (parliament, business and industry, churches and religious organizations, courts and legal system, schools and educational system); attitudes towards the influence of religious leaders on vote and government; judgement on the power of churches and religious organizations; doubt or firm belief in God (deism, scale); belief in a life after death, in heaven, in hell, in religious miracles, in reincarnation, in Nirvana, and in supernatural powers of deceased ancestors; attitudes towards the Bible (or appropriate holy book); attitudes towards a higher truth and towards meaning of life (scale: God concerns himself with every human being personally, people can do little to change the course of their lives (fatalism), life is meaningful because God exists, life does not serve any purpose, life is only meaningful if someone provides the meaning himself); own way of connecting with God; we each make our own fate; turning point in life respondent made new commitment to religion; religion of mother, of father and of husband/ wife/ spouse; religion respondent was raised in; frequency of church attendance (of attendance in religious services) of father and mother when the respondent was a child; personal frequency of church attendance of respondent at the age of 11-12 years; frequency of prayers and participation in church activities; self-assessment as religious; self-assessment as a follower of a religion and/or as a spiritual person; belief in lucky charms, fortune tellers, faith healers and horoscopes; respondent had a "born again" experience; picture of God (mother - father, master - spouse, judge - lover, friend - king); world image: much evil vs. much good, man is good vs. corrupt; trust in people or can't be too careful; attitudes towards the benefits of science and religion (scale: modern science does more harm than good, too much trust in science than faith, religions bring more conflicts than peace, intolerance of people with very strong religious beliefs); attitude towards truth in religion (very little truth in any religion, basic truths in many religions or truth only in one religion); law conflicts with religious principles; accept person from different religion: Marrying a relative; attitude towards public meetings and publications on the internet or social media/books by religious extremists; shrine/ altar in respondent's home; visit of holy place; religion helps people to make friends and to gain comfort; personal attitude towards Christians, Muslims, Hindu, Buddhist, Jews, Atheists or non-believers.

Demography:

sex; age; marital status; steady life partner; education: years of schooling; highest education level; current employment status (respondent and partner); hours worked weekly; occupation (ISCO 1988) (respondent and partner); supervising function at work; trade union membership; household size; child in household; party affiliation (left-right); participation in last election; attendance of religious services; religious main groups (derived); Top Bottom self-placement; subjective social class; place of living urban – rural; household income groups (derived).

Additionally coded: ID number of respondent; unique cumulation respondent ID number; ISSP Module year; country; country sample; country sample year; weighting factor; administrative mode of data collection.

3.1.1 This ISSP Cumulation

This ISSP cumulation includes all content related ISSP variables that exist for at least two years, thoroughly cumulated, harmonized if needed and documented. For the demography part of the dataset a pragmatic approach was taken. The cumulated datafile covers all key demographic indicators (see 3.1) where sufficient information for all years is available. National-specific variables (region and the un-derived information on national degree, national income and national denomination) are not included. They can easily be matched in from the original modules via the original case ID variable, if necessary. The Variable Report at hand documents all harmonization related issues. Reference is made to the documentation of the original modules at some points.

3.2 Countries

The cumulated dataset contains data from 38 countries. *Table 3.1* shows all these countries and the years in which each country participated. In some cases, it is important to identify subsamples within a country sample (comp. c_sample). This pertains to three countries: Germany, Israel, and the United Kingdom. Both the German and Israeli surveys oversample parts of their respective populations: East Germans in the case of Germany and Israeli Arabs in the case of Israel. Consequently, analyses of the German and Israeli data at country-level are not representative of their respective populations unless they are properly weighted. Design weights to adjust for the overrepresentation of one part of the population are available for most but not all modules (comp. variable weights). For the United Kingdom, there are independent surveys for Great Britain and Northern Ireland. Please note that, currently, the data from these two surveys cannot be integrated to form a representative sample of the United Kingdom, because weighting factors to adjust the populations sizes are not available.

3.3 ZA8792: Dataset structure and variable crosswalk

- **Position:** Position of variable in the cumulated dataset
- **Variable name:** Variable name in the cumulated dataset.
- **Variable label:** Variable label indicating the content of the question. All substantial variable labels contain a prefix encoding the years in which a variable has been surveyed (a = 1991, b = 1998, c = 2008, d = 2018; example: ‘ab’ means this variable was part of the surveys in 1991 and 1998).
- **ZA2150 (1991) to ZA7570/ZA7630 (2018):** Variable name in the cross-section datasets, empty if variable not part of the cross-section survey.

3.3.1 Archive and identification variables

These administrative variables are used for identifying datasets, respondents, and countries.

The GESIS Archive Version variable includes the version and release date of the dataset, composed as a string variable with three numbers (e.g., v1.0.0):

- The major number is incremented when there are changes in the composition of the dataset (e.g., additional variables or cases).
- The minor or second number is incremented when significant errors have been fixed (e.g., coding errors, misleading value labels).
- The third or revision number is incremented when minor bugs are fixed (e.g., spelling errors in variable or value labels).

The dataset contains both the original case ID used in the cross-section files (caseid) and a newly created unique case id for the cumulated dataset (cumu_id).

Different country codes identify each case as belonging to one country. All country codes have been harmonized to the current ISSP standard, which is based on ISO 3166. The variable c_sample_year is a cumulation-

specific variable, not available in the integrated data files. It combines country information and the year of the module).

3.4 Data preparation

3.4.1 Harmonization of module variables

For the module variables mainly the coding of missing values needed to be harmonized. Please see section 3.5. for the missing value coding scheme.

3.4.2 Harmonization of background variables

The standards for background variables used in the five cross-section surveys cumulated in this dataset have changed considerably over time. Up until the 2009 survey, the repertoire of background variables has been extended and standardized. The 2018 survey, however, used a substantially revised set of indicators. The harmonization of background variables was guided by the aim to identify the overlapping information and ensure that key demographic indicators are available from all five surveys.

This data cumulation contains two special variables, that only appear in cumulated data files. The first is the income group (**INCOME**), divided into low, middle, and high incomes. Since income in the ISSP is measured country-specifically (currency, period: monthly/yearly, individual categories) it has never been harmonized in official datasets before. For the Basic Cumulation, a rough, three-category (low, middle, high), harmonized

income-group indicator was generated. The assignment took place based on the relative position of the respondent in the national sample, which means that each category covers as close to 33.3% of the sample as possible. The second variable is **CHILDDH**. The information on the number of children in the household was collected very heterogeneously across countries and module years. Since they could not be harmonized, the new dichotomous variable at least captures the information on whether there are any children in the household at all.

3.4.3 Harmonization of occupational codes

ISCO-88 (ISSP 1991, 1998 and 2008) and ISCO-08 (ISSP 2018) have been used in the Religion series. To provide the broadest common code base, the available ISCO codes have been converted into ISCO-88 for this cumulated dataset (comp. ISCO88/ SPISCO88). All ISCO-Conversions are based on:

3.6 Weighting

Please note, that there is no total population weight to be used for international comparison. While all ISSP datasets contain a weighting variable, the weights in this variable do not incorporate a common weighting scheme that can be applied to all countries of the same ISSP module.

In the Study Description/ Technical Report and/ or in the background variables documentation of each country you will find more detailed information on the kind of weights that are provided. You can see whether

- a design weight
- weights to adjust for non-response bias or
- a combination of these both weights above or
- different weighting procedures

are applied. Provision of a design weight is mandatory for countries using household-based sampling methods, as these require compensation for the lower selection probabilities of persons in larger households. If no weight is provided, the variable WEIGHT is coded to 1.0. Otherwise, the weighting factor is unequal 1.0 (but greater than 0).

3.7 International documentation standard

The variable documentation is set up in accordance with the international metadata specifications for the social sciences, established by the Data Documentation Initiative <DDI>. The Variable Reports are based on the XML representation of DDI version 2. The documentation combines the wording and sequence of question components (question text, interviewer instruction, response categories, etc.) from the Basic Questionnaires

with the variable description (variable name, values, and labels) of the dataset. This basic variable documentation is complemented by additional information, e.g. general notes, descriptions of harmonization steps, etc.

4 Guidance on the variable documentation

The variable documentation part of this Variable Report describes each variable in the data file including all relevant information for this variable, such as the single question components or further notes. Due to the complex nature of the cumulated data, no crosstabulations or descriptive statistics have been added. The variable documentation is set up by means of the GESIS Dataset Documentation Manager (DSDM) and in accordance with international metadata standards (DDI-Codebook/XML).
